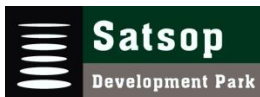

OFFICIAL EXHIBIT GUIDELINES

Saturday, March 20, 2010

Aberdeen High School Gyms and Commons

9:00 a.m. –4:00 p.m.

1. CONTRACT FOR SPACE RENTAL:

This request for space, full payment, and the notice of acceptance by the Grays Harbor Chamber of Commerce together constitute a contract for the right to use the space. Full payment is required at the time of space reservation. Exhibit rental fees per space: For Grays Harbor Chamber Members, One Space @ \$250 (**\$275 for Chamber Member's who register after February 21st**) Non-Members \$495; One Bite of Grays Harbor Space, \$225, Non-Member \$400, (Food Court includes a site only. No curtains, table or canopy are provided.) Sponsorships \$1,000 or \$3,400 in-kind (Sponsorships include two booth spaces and are limited.)

2. EXPO EXHIBIT SPECIFICATIONS:

The rental space fee provides an exhibit area 10' wide by 8' deep, divided by 3' high Royal Blue curtained side panels and an 8' high curtained backdrop fabric. (Nothing may be pinned or taped to the fabric.) There is also an 8' table with fabric skirting and tops. Chairs are not provided and may not be borrowed from the high school as we recommend exhibitors not be seated or if seated to sit on stools to maximize their interaction with the public. All exhibits must be arranged so as not to infringe upon or hide other exhibits, obstruct the general view, or allow sound to carry beyond the booth space. Signs may not be hung from the ceiling or protrude above your 8' high space.

3. EXHIBITOR INSTALLATION:

The exhibit area will be available for move-in and installation on Friday, March 19th, between 11:30a.m. and 7:00 p.m. Aberdeen High School opens at 7:00 a.m. on Saturday. **Set-up must be completed by 8 a.m. on Saturday.** It is recommended that you not leave removable valuables unattended at your booth.

4. SUB-LEASING OF SPACE:

The exhibitor agrees that exhibit **space will not be sub-leased** except by approval of the GH Chamber of Commerce.

5. SPACE CANCELLATION:

Space cancellation after February 28, 2010 will forfeit total space fee.

6. LIMITATION OF LIABILITY:

Aberdeen School District, its management, and the Grays Harbor Chamber of Commerce, and its management, shall not be responsible for any loss of articles, breakage, damage or injury that may occur to the exhibitor, the exhibitor's employee or property, for any cause whatsoever, prior, during, or subsequent to the period covered by this contract. The exhibitor agrees to meet the Aberdeen School District insurance and marketing license requirements.

7. CARE OF EXHIBIT SPACE:

The exhibitor agrees to leave the exhibit area clean and free of debris and personal belongings. The exhibitor also agrees not to injure in any way the doorways, walls, floors, or any of the permanent fixtures or furnishings, including chairs, of Aberdeen High School. **Blue Painter's Tape may be applied to the floor and walls no other tape may be used on floor or walls!** The exhibitor agrees that for any violation of the above provision, regardless of cause, the exhibitor becomes financially responsible to the Aberdeen School District. Power cords in public walkways must be properly covered. Booths must be staffed at all times.

8. EXHIBIT HOURS:

The exhibit is open to the public on Saturday, March 20, 2010 from 9 a.m. to 4 p.m. **Exhibits must be staffed during these hours.** Saturday 8:00 – 8:45 a.m. is a networking time for Exhibitors. We suggest you browse by the other Exhibits at this time.

9. DISMANTLING:

NO dismantling may be done before 4:00 p.m. March 20, 2010. Violation of this policy is **unethical and unfair** to other exhibitors and the public and may result in not being able to participate in future EXPO's.
